

The first official day of winter is right around the corner, and winter weather won't be far behind if it hasn't already touched us by December 21.

Not many enjoy winter weather that alters our weekend or travel plans, but being prepared can help so much. Having a weather app like The Weather Channel, Weather Underground, AccuWeather, or Weather.gov on your phone can help you plan ahead.



As for road conditions SDDOT 511 is a very detailed app with forecasts, current conditions, closures, and pictures. Many states have their own apps, and although getting used to how one indicates what is on the ground can be

confusing, downloading a specific state before getting on the road may save you a lot of stress.

JVT/NVC Supports Local Schools

One of the benefits of doing business with JVT/NVC is that we provide support to your local school districts through a variety of sponsorships and donations, and through the payment of gross receipts taxes.

Each year we pay gross receipts taxes on all of the revenue that the company collects. These taxes are then distributed to the school districts in each of the counties where the revenue was generated.

In 2023, JVT/NVC paid \$356,171.71 in 2022 gross receipts to fourteen school districts. When making decisions about your telecommunications purchases, take into consideration whether the company is a local entity such as JVT/NVC who provides monetary support each year to the schools in its service area, or whether it is, in fact, a national or regional company who does not provide such tax payouts.
